# Sustainability Policy

## 1. Overview

Delta Electricity Pty Ltd (Delta) owns and operates Vales Point Power Station and the Chain Valley Colliery and Mannering Colliery complex on the NSW Central Coast.

Delta's core business is mining coal for the generation of electricity. Our objective is to operate facilities for safe, efficient and sustainable mining and energy production. Our sustainability challenge is to balance the demand from the community and industry for an affordable and reliable electricity supply with the impact of the production of this electricity on the environment and the community where we operate.

Delta's approach to sustainability involves balancing economic, environmental, social and corporate governance aspects of the business so as to meet the needs of today without compromising the needs of future generations.

This policy describes how Delta will meet our corporate responsibilities and obligations to continually improve our sustainability performance with consideration of our shareholders and employees, the community and the environment.

## 2. Scope


This policy applies to the Vales Point Power Station, Chain Valley Colliery and Mannering Colliery operations and the local environment in which we work.

## 3. The Policy

Delta's Sustainability Policy has four core elements:

- i. Minimising the environmental impacts of our operations;
- ii. Being a good neighbour in the community where we operate;
- iii. Ensuring the safety and well-being of our people; and
- iv. Demonstrating responsible business management and operation of our assets.

To achieve this strategic policy and deliver value to shareholders, customers and the community, Delta will apply the following principles:

- i. Minimising our impact on the environment whilst providing a safe, secure and reliable energy supply;
- ii. conducting our operations in a manner that is consistent with the principles of ecologically sustainable development;
- iii. use resources efficiently and eliminate, minimise, reuse, recycle or safely dispose of waste materials;
- iv. develop and implement greenhouse gas management strategies to meet national, sectorial and facility-based emission reduction obligations;
- v. improve the resilience of our infrastructure to physical climate hazards and cyber security threats to minimise the risk to continuity of essential services;
- vi. maintain and enhance workplace health, safety, wellbeing and professional development for our staff;
- vii. engage with staff and external stakeholders on significant sustainability matters;
- viii. foster and support local programs and projects that enhance community well-being and improve local environmental outcomes;
- ix. maintain good corporate governance practices;
- x. ensure that goods and services procured by Delta are not the product of modern slavery and that our contractors maintain business practices and workplace standards comparable to our own when operating on our site; and
- xi. measure and report our performance in meeting our sustainability objective and target continual improvement in sustainability performance.


## 4. Governance and Accountability

The Board has oversight of Delta’s management and performance in relation to safety, environment, corporate governance and community matters.

The Board Audit and Risk Committee, Environment Committee and Work, Health and Safety Committee advise and assist the Board in the management and performance in meeting our sustainability objective and targets.

The Leadership Team is responsible for the implementation of this Policy and the Executive Manager Sustainability is responsible for the periodic review of this Policy.
