All Network and Metering Charges will be passed through at cost.

*kWh* stands for kilowatt hour and is the unit of measure for your electricity bill.

*LGC, STC, ESC* and *VEEC* Charges for a Billing Period is an amount calculated as the actual metered consumption of electricity at a Connection Point for the Site, adjusted by the applicable Loss Factors, multiplied by the LGC, STC, ESC or VEEC Rate (determined as the product of the LGC, STC, ESC or VEEC price in \$/certificate and the renewable power percentage).
