Operational Overview - David Morris

Safety & Health

Advised the members of the following safety details;

- Details regarding recent LTI.
- New mandatory alcohol and temperature testing at Vales Point.
- Flu vaccinations.
- Upgrade to switchboard protection to reduce arc flash.

Production

- Unit 5 is in service. YTD availability 82.36%
- Unit 6 is in service. YTD availability 86.82%

Coal Supplies

- Chain Valley mine mini wall coal and herringbone.
- · Mandalong mine deliveries via conveyor.
- Minor volume via trucks.
- Coal Handling Plant pylon repairs.

Asset Management Update - Vince Reedy

Projects

An overview and update on the planned projects for the power station was shared. Including details of the DCS upgrade and VP6 Turbine new intermediate pressure cylinders that was completed in the outage in April. Further details on the outage work scope were also shared.

Environmental Update – Kerrie Davis

Community Enquiries

Outlined the environmental and land management issues which were raised in the last 3 months and confirmed that all community enquiries are investigated, and appropriate responses and actions are provided. Also confirmed the Delta Community Incident Information number (1800 115 277).

March 2021 Storm Event

- As a result of the heavy rainfall the Vales Point ash dam over-boarded to the Wyee cutting on 21 March. The environment protection licence (EPL) permits discharge from the ash dam where >400mm rain has fallen in the prior 31-day period.
- Daily water sampling and analysis was undertaken as per EPL requirements.
- One sample collected 25 March exceeded the EPL limit for suspended solids (sample result = 74mg/L). The EPA were notified of the exceedance upon receipt of the sample results.
- The EPA advised Delta that given the nature of the storm event, they do not propose taking action as a result of the limit exceedance.
- Given the poor water quality within Wyee and Mannering creeks at the time, only one
 exceedance of TSS is an excellent result.

Nitrogen Dioxide Air Emission Limits

- Application submitted to the EPA to extend classification of Vales Point units as Group 2 for the purpose of NOx emission limits.
- Delta has also submitted a proposal to the EPA to complete an air emissions modelling study to support the application.
- New burner tips are being installed in unit 6 as part of the current major outage. This
 work is expected to significantly reduce unit 6 NOx emission levels
