Projects

An overview and update on the planned projects for the power station was shared. Including details of the VP5 air heater basket replacement which will take place during the Unit 5 major outage in March 2023, further details of the outage work scope were also shared.

Environmental Update –

Community Enquiries

Outlined the environmental and land management issues which were raised in the last 3 months and confirmed that all community enquiries are investigated, and appropriate responses and actions are provided. Also confirmed the Delta Community Incident Information number (1800 115 277).

Ambient Air Monitoring

The new air quality monitoring station (AQMS) at Mannering Park has been installed. The station will monitor NOx, SO2, PM 2.5 particulates and meteorological conditions. AQMS was installed, operated, and maintained by a suitably qualified air specialist.

Ash Dam Dust Suppression

- Dust suppressant polymer was applied to the southeast portion of the ash dam on 18 November 2022.
- The dust suppressant was applied using light aircraft and a 'HydroRig' equipped with 2 water cannons.

Bushfire Management

- All planned burns on Delta landholdings outlined as due in the current Bushfire Risk Management Plan have been undertaken by NSW RFS.
- Delta currently inspecting and prioritising asset protection zone (APZ) slashing.
- Mannering Park Scout Hall APZ inspected this week and clearing works in planning stage.
